BRADFORD PEVERELL ANNUAL PARISH MEETING

Held in the Village Hall on Thursday July 3rd, 2014

Democratic Period - Villager David Evans raised the subject of the new wheelie bins and waste collection service. He was concerned that some villagers would not be fully aware that they could refuse them if they had no suitable storage area, they could request smaller ones if they were a small household or they could request help with the moving of bins if they were not able to do it themselves. He was concerned about the introduction of wheelie bins in an "Area of Outstanding Natural Beauty" and how they would spoil the appearance of the village.

D. Cllr Sarah East answered that the bins were being introduced to prevent seagull and animal damage to black bags and to encourage more recycling.

The subject was discussed and it was decided to do a leaflet drop through the village explaining all the options and asking parishioners to be vigilant in putting their bins away. Cllr Denning offered to draft the letter, others volunteered to help with delivery.

The verge cutting contractors had been through the village and area but it was pointed out that they do not cut around signs and seem to miss chunks regularly. Cllr Howard will action and check zones. Also the central reservation on the A37 has become a hazard to visibility.

D. Cllr Sarah East reported that the Local Plan Inspectors were not satisfied with the amount of new housing to be built. It has been suspended temporarily. They've had consultants look at the plan and they have reduced the length of the plan and increased the amount of development to 775 per year for the area (WDDC plus Weymouth and Portland BC). Hopefully these changes will be accepted. They are also looking at further amalgamation of services and checking others working practices.

Localism - Cerne Abbas Plan has just been completed. Cllr Denning proposed that we look at starting to produce a Neighbourhood Plan but there is a lot of work involved. Charles Street development - Simon's are putting in plans in July.

- <u>Village Hall</u> Dave Ackerman nothing to report
- <u>Amenity and Jubilee Fields</u> Cllr J Wilson resigned from the PC with immediate effect but she did suggest a replacement who uses the fields with his family regularly. Cllr Howard will approach him and if he is willing to join us he can be co-opted onto Council as we still have another vacancy that we have been unable to fill.

Tim Collins proposed a Vote of Thanks to Jan for all her past work and all agreed that she would be sadly missed.

- <u>Women's Institute</u> Cllr Diment Thriving despite low membership. Still trying to get something together to put on website.
- <u>Muckleford</u> Dr Buck See Planning. The site in question is gradually accumulating rubbish. The parapet of the bridge has been damaged yet again and has been reported to Highways.
- <u>DAPTC</u> No rep at present.

7 Officers Reports

- <u>Village Maintenance</u> Cllr Howard The road sweeper had been through the village and did quite a good job except around parked cars. The cross drain above the Church was cleaned out and a number of potholes have been repaired. The length of the grass on the A37 central reservation has been reported as in need of a cut for safety reasons.
- <u>Transport</u> Cllr Collins He has contacted Stratton PC re the possibility of reopening Stratton Halt and will hopefully ave their comments in time for next meeting.
- <u>Footpaths and R.O.Way</u> Dave Ackerman A Muckleford resident has uncovered evidence of the original path. (Permissive paths are cheaper to establish) He is investigating other possibilities. The Bradford Peverell to Stratton path has been reported as being overgrown.
